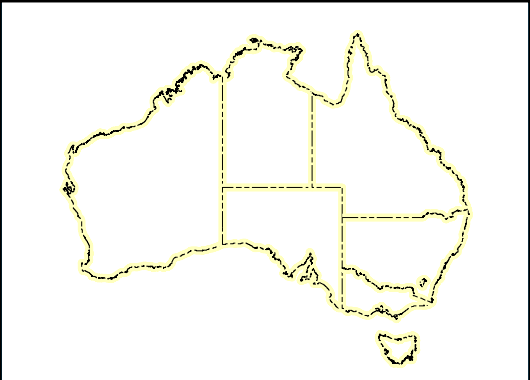

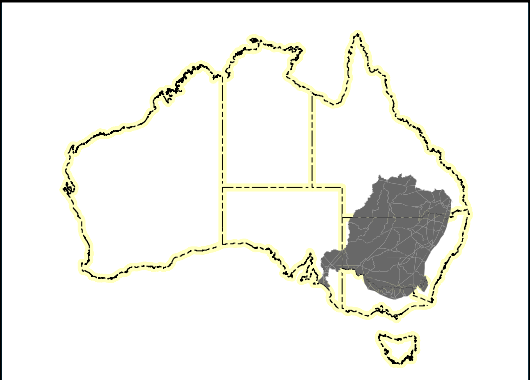

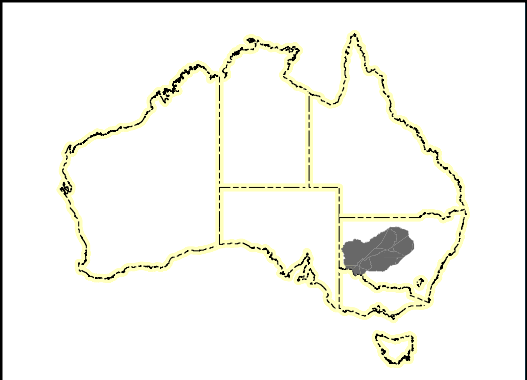

Melanotaenia fluviatilis

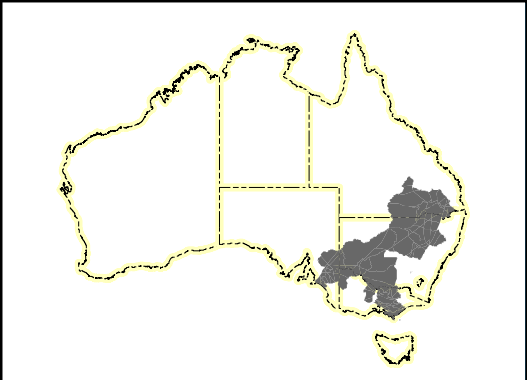

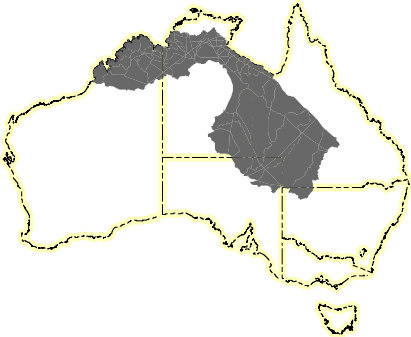
